## Privacy Policy

In our company "UNISOL SLOVAKIA s.r.o." we have developed the following terms and conditions for the protection of personal data in accordance with our company, brand names, trademarks, obligations and commitments on privacy. The following part of the terms and conditions contains a contextual part, which publishes and establishes the protection of privacy, procedures for the collection and dissemination of information of all our brand name "MIXSTOREONLINE" which include our company "UNISOL SLOVAKIA s.r.o."

By using the pages that belong to "MIXSTOREONLINE" or "UNISOL SLOVAKIA s.r.o." or related services are considered as acceptance of this agreement with the user than you are also agreeing to the following privacy policy regulation. If you do not agree to this privacy policy statement, then we will not authorize you or allow you to use the web interface of our brand name "MIXSTOREONLINE" or neither our company "UNISOL SLOVAKIA s.r.o." and related services provided by us for public use. If you do not fully respect and comply with our policy regulation but you still continue using our web interface then we will not take any responsibility for damage or losses you have made without our prior consent.

Explanation of the terms "WE", "US", "OUR", "COMPANY", "MIXSTOREONLINE" or "UNISOL SLOVAKIA" which also includes "UNISOL SLOVAKIA s.r.o." and all our affiliates and other representatives of the company.

### 1. What information do we collect?

"MIXSTOREONLINE" or "UNISOL SLOVAKIA" collects your information when you register on the "MIXSTOREONLINE" or "UNISOL SLOVAKIA" website interface and when you visit "MIXSTOREONLINE" or "UNISOL SLOVAKIA" pages.

**Personal Information:** We may collect the following types of personal information in order to provide you with the use and access to the "MIXSTOREONLINE" or "UNISOL SLOVAKIA" site, services and tools, and for any additional purposes set out in this Privacy Policy:

- Name, and contact information, such as email address, phone number, mobile telephone number, physical address, and (depending on the service used) sometimes financial information, such as bank account numbers;

- personal information you provide to us through correspondence, chats, dispute resolution, or shared by you from other social applications, services or websites;
- additional personal information we ask you to submit to authenticate yourself if we believe you are violating site policies (for example, we may ask you to send us an ID to answer additional questions online to help verify your identity);
- information from your interaction with our sites, services, content and advertising, including, but not limited to, device ID, device type, geo-location information, computer and connection information, statistics on page views, traffic to and from the sites, ad data, IP address and standard web log information.

**Aggregate Information:** “MIXSTOREONLINE” or “UNISOL SLOVAKIA” collects non-identifying, general, generic and aggregate information to better design our Web site and services.

**Non-Personal Information:** “MIXSTOREONLINE” or “UNISOL SLOVAKIA” may collect non-personal information as you use “MIXSTOREONLINE” or “UNISOL SLOVAKIA” web interface. When you use the site, “MIXSTOREONLINE” or “UNISOL SLOVAKIA”, third-party service providers (e.g. Google Analytics), and partners may receive and record non-personal information from cookies, server logs, and similar technology from your browser or mobile device, including your IP address.

We may combine some Non-Personal Information with the Personal Information we collect about you while you are using our web interface. Where we do so, we will treat the combined information as Personal Information if the resulting combination may be used to readily identify or locate you in the same manner as Personal Information alone.

## 2. How do we store your information?

We use hosting provider, therefore your information may be transferred to and stored on servers in various locations both in and outside of EU.

“MIXSTOREONLINE” or “UNISOL SLOVAKIA” maintains and control of your information which are distribute to us while using web interface. We protect your information using technical and administrative security measures to reduce the risks of loss, misuse, unauthorised access, disclosure and alteration. Some of the safeguards we use are firewalls and data encryption such as secure socket layers, physical access controls to our data centres, and information access authorisation controls.

### 3. How do we use your Information?

When you use the “**MIXSTOREONLINE**” or “**UNISOL SLOVAKIA**” web interface, we may request certain information. “**MIXSTOREONLINE**” or “**UNISOL SLOVAKIA**” does not share none or any of your personally identifiable or transactional information with any person or entity, other than as set out in this policy, unless law force or particular jurisdiction is like to obtain them from us to stop or fight crime. No other third party receives your personally identifiable information or other transactional data except for those with whom you have transactions and share that information by using them own payment gateway. The information we collect is used to improve the content of our website interface, used to notify consumers about updates to our website and for communications, such as customer support service.

**Communications:** We may send you a welcome email and other transactional emails for operational purposes, such as billing, account management, or system maintenance. We may also send you promotions, product announcements, surveys, newsletters, developer updates, product evaluations, and event information or other marketing or commercial e-mails. You can opt out of receiving these email communications from “**MIXSTOREONLINE**” or “**UNISOL SLOVAKIA**” at any time by unsubscribing using the unsubscribe link within each email or emailing us to have your contact information removed from our email list or registration database.

**Marketing:** You agree that we may use your personal information to tell you about our services and tools, deliver targeted marketing and promotional offers based on your communication preferences, and customise measure and improve our advertising. You can unsubscribe from emails at any time by clicking the unsubscribe link contained in the email.

We do not rent, sell, or share Personal Information about you with other people or non-affiliated companies for marketing purposes (including direct marketing purposes) without your permission. We may use and share Non-Personal Information for our marketing purposes, including, without limitation, marketing on other websites. For example, we may use the information to control the number of times you have seen an ad, deliver ads tailored to your interests, and measure the effectiveness of ad campaigns. You can prevent us from tailoring our ads to you on other websites by deleting your cookies (see below).

### 4. Sharing your Information

We disclose a privacy policy and information for data protection to respond to legal laws and legal requirements, which may apply to all our policies, respond to allegations that a record or other content violates the rights of others, and help protect the human rights and property or safety of each of us or business

representative who legally represent our company. All information will be disclosed only in accordance with applicable laws and regulations particular jurisdiction where the business is located. As stated above, we do not disclose your personal information to third parties for their marketing purposes without your express consent and valid permission which was granted us by you prior to this agreement.

We may disclose personal information to our related parties, suppliers and service providers from third parties and foreign service providers for any of the above purposes. We take reasonable steps to ensure that overseas recipients of your personal data do not violate personal data protection obligations related to your personal information and they will not be misused for any other purpose than provide delivery or shipment to goods you have other from us by using our website interface.

We may also provide your personal data to entities located outside the EU if is it requested by law force or legal procedure is in the place to fight crime or fraud attempt. We may share common none sensitive information with advertisers and other third parties as long as these services are agreed and privacy policy is fully respected upon request send to us for obtaining this information for marketing techniques. The company "**UNISOL SLOVAKIA s.r.o.**" or brand name "**MIXSTOREONLINE**" uses industry-standard encryption technologies to transmit and receive data about customers and transactions in personal contact with customers, which they can also do through our website interface if they are planning to use it electronically to purchase services or very well organize and provided by our company.

All payment gateway we use is base on secure industry-standard encryption technologies to transmit electronic payments via verified and secure service provider such as **PAY-PAL, Stripe, Skrill, WorldPay** or any other legit provider approved by financial conduct authority.

## 5. Cookies

Cookies are pieces of data assigned by a web server that uniquely identify the browser on your PC Desktop, Laptop or Mobile device. Our website interface which run via "**MIXSTOREONLINE**" or "**UNISOL SLOVAKIA**" uses cookies called "persistent" cookies to enable the site to remember you on subsequent visits, speeding up or enhancing your experience of services or functions offered.

Cookies also enable our systems to gather information about your navigational patterns through the site. You have the option to disable cookies at any time through your browsers. We may also store your website activity in cookies which may be used by third party vendors, including Google, to serve ads based on your behaviour on our website.

The third party vendors (e.g. Google Analytics) may receive and record non-personal information from cookies, server logs, and similar technology from your browser or mobile device, including your IP address. You may opt out of Google's use of cookies by visiting the Google advertising opt-out page

## 6. Accessing and updating your Information

We will not charge for simply making the request and will not charge for making any corrections to your personal information.

There may be instances where we cannot grant you access to the personal information we hold or pieces of data we gather about you or your activity while you are using our website interface via “**MIXSTOREONLINE**” or “**UNISOL SLOVAKIA**”. For example, we may need to refuse to give you access if granting permission or access would interfere with the privacy of others or if it would result in a breach of confidentiality. If that happens, we will give you written reasons for any refusal and we will forwarded to you by electronic communication or by post.
